## Opening Statement

(Samantha Reali)

Good Afternoon, ladies and gentlemen of the Jury. We are gathered here today on behalf of my defendant, Mr. Victor Frankenstein, who is being sued by the plaintiff, the Creature. Today, we will begin to listen to the allegations the creature has fabricated against Mr. Frankenstein. Why? One can only assume, it for money! (Elizabeth Poirier)**

**Q. Please state your name for the court.**

Elizabeth Frankenstein.

**Q. What was your relationship to Victor Frankenstein?**

He was my very loving husband.

**Q. How and when did you meet Victor?**

I met Victor when we were very young. I was adopted by the Frankensteins, who saved me from poverty.

**Q. So you have known him your whole life? How would you describe him?**

**Q. So how did you die?**

I was strangled violently by the Monster on my wedding night.

**Q. Do you believe that Victor had anything to do with this?**

**Q. Please state your name.**

**Medical Examiner Questions  
(Jenna Grossguth)**

**Q. Please state your name and profession.**

My name is Clarice Everwood and I am a psychiatrist.

**Q. How would you say Victor's mental health was before he left to attend the University of Ingolstadt?**

Victor had his whole life ahead of him, and he was excited to get it started, but he exhibited no signs of any mental illness.

**Q. How would you say Victor's mental health was after the Creature murdered many of his friends and family?**

As anyone would, Victor suffered from depression, as anyone and everyone that he cared about was now eradicated from his life. He also suffered from anxiety and paranoia, as he was being followed by the Creature and never knew when he would strike next.

**Q. So, in your professional opinion, would you say that Victor did not suffer from any mental disorders before the Creature killed these people?**

Yes

**Q. Did the Creature say, "Remember that I have power; you believe yourself miserable, but I can make you so wretched that the light of day will be hateful to you. You are my creator, but I am your master;—obey!"**

Yes

**In your professional opinion, what does this mean to you?**

**Ethical Questions  
(Elizabeth Pelletier)**

**Q. Please state your name.**

Elizabeth Pelletier

**Q. Please elaborate?**

**Waldman Questions  
(Cara Bergeron)**

**Q. State your name for the court**

Professor Waldman, of the University of Ingolstadt

**Q. What was your relationship with Victor?**

**Q. What kind of student was Mr. Frankenstein?**

He was very ambitious and sought out answers

**Q. Where were Frankenstein's interests?**

He paid little attention to his peers, and focused on modern chemistry, physiology, and other physical sciences.

**Q. What did you teach to Victor?**

I showed him the side effects of electrical stimulation on a body and other common phenomenon.

**Q. Did Mr. Frankenstein ever appear distracted?**

Not from his work, he was always focused on his work

**Q. Would you say he was a superb student?**

He was more passionate than others, making him excel in comparison

**Q. Did you ever assist him with his projects or anything similar?**

Yes, I often gave him pointers and input from my years of learning and dabbling in similar areas, but never actually aided him physically.

**Q. What did your previous work include?**

I wished to extend life and the style of living for all people. Strictly humanitarian work.

**Q. Would you say Mr. Frankenstein had fulfilled your hopes of extending life?**

Absolutely! This man is a gifted man of science and has done nothing except help humans live longer! His work has paved the way for future scientists and doctors

**Q. Did Mr. Frankenstein ever appear to have bad intentions?**

Never. He was only trying to help our species.

**Cross Examination for Behavioral Analyst**

**Q. Please state your name and profession**

**Q. Exactly what does a behavioral analyst do?**

Q. Because you study learning and behavior, are you saying that what the Creature did was morally right behavior?

Q. Do you believe that the Creature's environment played a role in his behavior?

**If yes,** Is it not true that the Creature left on his own will and as a result, put himself in this environment?

**If no,** So would you then agree that the Creature made his own choices and chose to maliciously murder multiple people?

Q. Would you say that the Creature is intelligent?

**If yes,** Why did he willingly kill multiple people then, as many intelligent people know there are other smart ways to handle your problems?

**If no,** Wouldn't you say that the Creature had to have some level of intelligence to frame Justine for the murder of William?

Q. Would you say the Creature had an aggressive nature?

**If yes,** When would it stop? Would he even stop once he got his revenge on Victor? Or would he go around murdering more innocent people, especially if you say he had an aggressive nature?

**If no,** Why would he attack someone who was not attacking him then?

Says victors work is ethical “elongating lives”

Creature came back for revenge for wrongdoing not guidance

Q. Please state your name for the court.

Q. How were you first acquainted with Victor?

Q. During Victor's efforts in creating the creature how would you say he acted?

Q. How was the state of Victor during night of the creation being brought to life?

Q. you could say that he was emotionally and physically distressed at this time correct?

**if no**, then how would you describe his state then?

Q. Did you see much of Victor after that night?

Q. Could you tell us where you were located the night of your death.

Q. Who killed you that night?

Q. How were you killed?

Q. Do you know why this person decided to kill you?

Q. There had to be a reason for the person to kill you. Could you tell us why?

Q. Are you distraught at the fact the Creature killed you out of revenge towards your friend Victor?

Q. You say that Victor is your friend yet you side with the Creature. Why?

### **Cross Examination for Mr. DeLacey**

Q. Please state your name.

Q. Is it true that you are blind?

Q. Is it true that you were unaware of the Creature living around your home?

Q. Is it true that at the time of the Creature eating your food and using your resources, you and your family were living in poverty?

Q. Did the Creature eating your food put a strain on your family's food resources?

Q. Did the Creature ask to live in your home?

Q. Do you feel that your son beating the Creature was justified?

Q. Would you feel threatened by an 8-foot creature, had you been able to see him?

Q. Why are you siding with the Creature who you are so terrified of rather than Victor who had not done anything to you?

### **Cross Examination for Justine**

Q. How would you describe Victor?

Q. Did it ever cross your mind that Victor may have been spending time focused on studying and getting a good education, rather than writing letters?

Q. Has he ever given you any reason to distrust him?

Q. Did it ever cross your mind that the Creature may have framed you?

Q. How do you think you would feel if your younger brother was slaughtered unexpectedly?

Q. Is it true that ultimately, you plead guilty to a crime you did not commit, resulting in a foreshadowed execution?

Q. Did you know that it is illegal to lie under oath (in court)? (“If the defendant pleads guilty, the law requires that he do so honestly. Often, the defendant must state, under oath and in open court, what he did that constituted a crime”)

Q. In your opinion, is it a crime to have secrets (when you feel that you are protecting the ones you love)?

### **Cross Examination for Krempe**

Q. When did you first meet Victor Frankenstein?

Q. What was your relationship with Mr. Frankenstein like?

Q. Did you ever voice your opinion about or publicly humiliate Mr. Frankenstein?

Q. Would you say your thoughts of Mr. Frankenstein were low?

Q. Could you share your thoughts on Mr. Frankenstein's prior knowledge on the subjects you educate?

Q. How did you feel about your correspondent's treatment of Victor Frankenstein?

Q. Would you care to share your opinion on Victor Frankenstein's work?

Q. Did you despise Victor Frankenstein for his work?

### **Examination Questions for Ethicist**

Q. Is murder acceptable?

Q. Is killing defenseless humans justifiable?

Q. What do you think it means by the Creature being able to restrain himself from killing those who directly killed him, but not the Frankenstein's?

Q. Is the Creature guilty of murdering the innocents?

Q. What does murder say about a person's character?

Q. Is it ethical for someone who has learned the ways of humanity through the DeLacy's to have murdered and seek out revenge?

Q. Is it ethical to save a life?

Q. So what Victor did, furthering science to save lives, is that unethical?

Q. Is it revenge ethical?

### **Closing Statement**

(Kaitlyn Parry)

Ladies and Gentlemen of the Jury:

As this case concludes this morning, I hope you now have come to realize that not only is Victor Frankenstein innocent of the charges of neglect, malpractice, and emotional and physical distress that have been brought against him by his Creation, but that Victor is truly a victim himself. After the passing of his mother, he saw firsthand the enormous impact the loss of a loved one can have on an entire family. For this reason and this reason only, he set out to discover way to save lives, to elongate life, and to restore life to those it has been taken from, and therefore, restoring life to all those who loved that person as well. In return, he was rewarded with the murders of the people whom he loved and nothing but a life filled with agony and torture.

It has been agreed upon by both parties that murder is unethical and unacceptable. It has been agreed upon that it is ethical to save and elongate life. It has been established that Victor never truly violated the hippocratic oath, he is not even yet a doctor, he has not even yet to take the oath. Victor was not a parent to this Creation; he was a scientist, the Creation his scientific experiment. Victor never insulted or mistreated the Creature. So then, how could you say he is guilty of malpractice and causing this Creature the emotional and physical distress he is accused

of? Was Victor not the one haunted and stalked by the Creature, the one whose family was killed by this creature, the one who was virtually left alone in the world due to the actions of another?

The Creature stood up on his own two feet, walked into this courtroom with his fully functioning body, and testified using his very own voice. With that voice, he admitted to the murders of multiple people. Does this not require some level of intelligence? He says he was angry. That is absolutely no excuse for murdering four innocent human beings. He was enraged with Victor. This was his revenge. For him to state that he did not know what he was doing as he was not taught right from wrong, this is clearly contradicted by him stating that his actions were backed by rage towards Victor. He even observed morals in the Delacey's. For him to continue to say "I don't recall" he displays the intelligence to know when he has clearly unintentionally admitted that he was wrong.

Victor was constantly looking over his shoulder, worried about what the Creature's next move would be. He lost all those he loved to this monster. What had Victor, a kind man with incredible intentions, do to deserve such a thing? Is this not causing him extreme levels of distress?

Ladies and gentlemen of the Jury, I ask you this: as you look around in this world and see all of the tragic things that occur, do you blame others for the actions of the individual that caused it? No. What makes this case any different? You cannot neglect something or someone who is not present in your life and made the decision not to be. You cannot be guilty of malpractice for restoring life and providing a working mind and a beating heart to a being in completely good health. You are not causing any emotional and physical distress to the being that is murdering all of those you love, rather you are suffering from it. For all of these reasons,

my client, Victor Frankenstein, is clearly innocent of all the charges brought against him by this being who he restored life to, who in turn, ruined his life. Thank you.
